The following items must be approved by the City prior to starting landscape work:

- 1. Check that your property is within City Limits

- 3. Schedule and complete Pre-Inspection
- 4. Wait for Issuance of Certificate of Participation and Approval.

CASH FOR GRASS TURF REBATE AGREEMENT

I agree that by virtue of these inspections, the City of Cotati makes no determination with respect to whether materials and equipment are free of defects, the quality of the workmanship, the suitability of the premises or the materials or equipment for the installation. I also understand that the installation of irrigation equipment and landscape materials described above may not result in lower water bills. I agree to defend, indemnify and hold harmless the City of Cotati, its directors, officers, agents and employees against any and all loss, liability, expense, claims, suits and damages, including attorney’s fees, arising out of or resulting from the installation of irrigation equipment and landscape materials.

By signing below, I agree that any carbon credits attributable to the water and energy savings from the installation of a low water use landscape initiated through the Program, if any, shall be held by the City.
