NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City Council will conduct a Public Hearing on **February 11, 2025, at 6:00 p.m.**, or shortly thereafter, in the Council Chambers of Cotati City Hall, 201 West Sierra Avenue, to consider the following matter:

The City of Cotati City Council will consider adoption of an update to the Santero Way Specific Plan (SWSP) which would increase and intensify land use densities and facilitate a residentially focused transit-oriented neighborhood surrounding the SMART station in Cotati. In addition to considering the Plan Update, the City Council will consider whether to find the Santero Way Specific Plan (SWSP) consistent with the SWSP Environmental Impact Report (EIR) and the General Plan EIR and whether to certify the SWSP Final EIR, which also analyzed the impacts of implementing Transit Oriented Development (TOD) policies on nine parcels totaling up to 15 acres outside of the SWSP area.

CEQA DETERMINATION: In conformance with California Environmental Quality Act (CEQA), the Community Development Department, Planning Division has found that this project has the potential to impact the environment. As such the Department has prepared an Environmental Impact Report to analyze these potential impacts and identify potential mitigation measures available to address those impacts, consistent with CEQA Section(s) 15084-15092.
