## NOTICE OF PUBLIC HEARING

**NOTICE IS HEREBY GIVEN** that the City Council will conduct a Public Hearing on **December 9, 2025, at 6:00 p.m.**, or shortly thereafter, in the Council Chambers of Cotati City Hall, 201 West Sierra Avenue, to consider the following matter:

Introduction and first reading of an ordinance to create the Santero Way (SW) and Transit Oriented Communities (TOC) zoning districts which would implement increased and intensified land use densities surrounding the SMART station and on E. Cotati Avenue. These Districts would implement changes on all the parcels in the Santero Way Specific Plan (SWSP) area and on nine parcels totaling up to 15 acres which front onto E. Cotati Avenue but are located west of the SWSP area.

CEQA DETERMINATION In conformance with California Environmental Quality Act (CEQA), the Community Development Department, Planning Division has found that this project has the potential to impact the environment. As such the Department previously prepared an Environmental Impact Report (EIR) to analyze these potential impacts and identify potential mitigation measures available to address those impacts, consistent with CEQA Section(s) 15084-15092.
